## Information Technology User Agreement

5. I will not use **IT** to send and receive emails and messages, nor will I use any form of social media during the school day
6. I will cooperate with other students to use the Internet as effectively as possible.
7. I will report any problems with the Internet use directly to my teachers.
8. If I find a site that is inappropriate I will exit immediately and report the incident to my teachers.
9. I will print out or download materials only when directed to do so by my teachers.
10. I will share my knowledge by assisting other students when needed.
11. I will not connect electronic devices to wireless networks except when given permission by my teachers to use the DCS student wireless network.
