- 1. In making this application, I understand and agree with the purpose of the Delta Christian School (the "School") as set out in the Delta Christian School Handbook and acknowledge that I am applying to enrol my child because of my earnest desire that he/she receive a Christ-centred education.
- 2. I understand that I am applying to enrol my child in the School and accept that the School reserves the right to accept or reject this application for any reason that the School, in its sole discretion, sees fit.
- 3. I understand that this application for the enrolment of my child is for the current school year only and that, if accepted, I must submit an application for re-enrolment each year. I accept that the School reserves the right to accept or reject any application for re-enrolment for any reason that the School, in its sole discretion, sees fit.
- 4. If my child is accepted by the School, I agree that he/she will be educated in accordance with the constitution and by-laws of the Delta Christian School Society (the "Society") and the various policies and procedures of the School, all as amended from time to time, and that my child is subject to the authority vested by the School in the principal and classroom teachers.
- 5. I understand and agree with the vision statement of the School, which requires the home, school, and church to work together to equip and nurture my child for a life of joyful Christian service. I understand that my obligation as a parent is to provide a Christian home environment. I agree to regularly attend and participate in a Christ-centred church with my child.
- I acknowledge that I have received, read and understood, and I agree with, the Delta Christian School Handbook, and I and my child agree to be bound by and to abide by any terms, requirements or rules contained in this document.
- 7. As a new parent at the school, I am invited to attend two parent orientation sessions (in October/November), and understand that attendance at both these sessions is a condition of membership in the Society.
- 8. I will make every effort to attend parent-teacher interviews.
- 9. I will pray earnestly for the School, and will seek to resolve all issues I or my child may have in accordance with the policies and procedures of the School. In doing so I will also adhere to the principles set out in Matthew 18:15 & 19.
- 10. I agree at all times to conduct myself in a manner consistent with the principles of the School and to act in the best interests of the School.

- 11. In recognition and support of the School community, I am invited to assist the School on a voluntary basis (i.e. committee work, classroom assistance, special projects).
- 12. I agree to pay tuition (which includes all fees and charges levied by the School from time to time) when it is due.
- 13. I accept that the School reserves the right to expel any child who fails to comply with the rules and regulations of the School or whose tuition remains unpaid.
